PRIVACY POLICY

O.I. Corporation d.b.a. OI Analytical (“OI”) respects your privacy. This Privacy Policy is provided to inform you of our privacy practices and the choices you can make about how personally identifiable information about yourself is collected and used. Once you choose to provide personally identifiable information, please be assured it will only be used to support the relationship between OI and yourself. OI uses your personal information for specific purposes.

OI will not disclose your personal information to any outside organization without your consent.

OI will not sell, rent, or lease your personally identifiable information to others. Unless we have your permission or are required by law, we will only share the personal data you provide with business partners who are acting on our behalf for the uses described above. These business partners, including those in the United States and other countries, are governed by our privacy policies with respect to the use of this data and are bound by appropriate confidentiality agreements. Data collected online may also be combined with information you provide when registering your ownership of OI products.

OI will take reasonable precautions to safeguard information you provide.

To prevent unauthorized access or disclosure, maintain data accuracy, and ensure appropriate use of information, OI has established appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect online.
